Group reorganisation and basis of preparation

The Company was incorporated in Bermuda on 22nd September, 1999 and remained inactive until 11th January, 2000 when the reorganisation (the "Reorganisation") of the Group was completed and the Company became the holding company of the Group. The Reorganisation has been accounted for by the Company using the merger accounting method in accordance with Statement of Standard Accounting Practice No. 27 "Accounting for group reconstructions".

(Loss)/ Earnings per share

The calculations of loss/ earnings per share for the three months ended 31st March, 2001 were based on the loss attributable to shareholders of HK\$436,000 for the three months ended 31st March, 2001 (2000: HK\$35,000) and on the 318,000,000 shares in issue for the three months ended 31st March, 2001 and on the weighted average of approximately 236,284,000 shares in issue for the three months ended 31st March, 2000. The number of shares for the three months ended 31st March, 2000 have been adjusted for the Company's Share Subdivision on 24th July, 2000.
