The Company was incorporated in Bermuda on 22nd September, 1999 and remained inactive until 11th January, 2000 when the reorganisation (the "Reorganisation") of the Group was completed and the Company became the holding company of the Group. The Reorganisation has been accounted for by the Company using the merger accounting method in accordance with Statement of Standard Accounting Practice No. 27 "Accounting for group reconstructions".

## Earnings/ (Loss) per share

The calculations of loss per share for the nine months ended 30th September, 2001 were based on the loss attributable to shareholders of HK\$4,408,000 for the nine months ended 30th September, 2001 and on the 318,000,000 shares in issue for the nine months ended 30th September, 2001

The calculations of earnings per share for the nine months ended 30th September, 2000 were based on the profit attributable to shareholders of HK\$800,000 for the nine months ended 30th September, 2000 and on the weighted average of approximately 290,861,315 shares in issue for the nine months ended 30th September, 2000. The number of shares have been adjusted for the Company's Share Subdivision on 24th July, 2000.
