Reference is made to the announcements of Changhong Jiahua Holdings Limited (the “**Company**”) dated 28 April 2015 and 6 November 2015 in relation to the proposed transfer of listing (the “**Transfer of Listing**”) of the Company’s shares from the Growth Enterprise Market to the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The Company submitted an application for the Transfer of Listing to the Stock Exchange on 28 April 2015 and subsequently made a re-submission to the Stock Exchange on 6 November 2015 (the “**Second Application**”). As six months have passed since the submission of the Second Application, the Second Application lapsed on 6 May 2016 and no re-submission has been made at this stage. Nonetheless, the Company may make re-submission for the Transfer of Listing as and when the board (the “**Board**”) of directors of the Company considers appropriate.

The Board takes the view that the lapse of the Second Application has no material adverse effect on the existing business operations and financial position of the Company and its subsidiaries.

The purpose of this announcement is to keep the shareholders and potential investors of the Company informed of the progress of the Transfer of Listing. Accordingly, shareholders and potential investors of the Company are reminded to exercise caution when dealing in the shares of the Company.
